Commentary

- A general abundance of fodder is reflected by price drops across most byproducts. Forage extenders such as almond hulls and malt combings are readily available and needing to be placed.
- Citrus pulp is also plentiful, and as a quality soluble fibre, will compliment some of the poorer quality forages we are likely to see once harvest is complete.
- Both brewers' grain and brewers' sweet grain have seen significant price drops, once again, partly due to the spring flush of grass in diets and the short shelf life of these products.
- The wet conditions continue across southern Australia, which is affecting companies' ability to move product both in and out of facilities in a timely fashion.
- New seasons solvent canola meal is being quoted for \$480 Ex northern Victoria and \$510 Ex Melbourne. A very significant volume of the crush capacity has already been contracted. With wet conditions and the canola seed not yet in the silo this could make for an interesting scenario.
