Commentary

- Potato supply has become an issue with planting conditions being unfavourable and a major shut down at a key processor. This is expected to be an ongoing issue for the remainder of the season. People seeking new potato based supply are now going onto waiting lists. Coupling this with lower Maize plantings, some farms will have issues with starch supply and will have to pivot to other products.
- DDG and Millrun byproducts are readily available with a sales push underway in Victoria and the New South Wales Riverina.
- Citrus and fruit waste are in good supply and quality has generally been excellent on farm. Dry matters should be confirmed with the vendor but have generally been closer to 20% DM rather than the 18% DM we expect.
- Food and Beverage Service in Melbourne is in full flight ahead of Christmas, and products such as bakery waste are seeing a spike in availability.
- Freight cost and availability remains one of the biggest issues in getting reliable supply and higher moisture products delivered economically.

There can be a wide variation in quality of byproducts and prices can vary based on product quantity and quality.
