New Zealand exporters can continue to supply SMP under Thailand's WTO global tariff quota, which is set at at least 55,000 tonnes annually, across four SMP tariff lines: 0402.10.41; 0402.10.49; 0402.10.91; and 0402.10.99.

Comment: Australia is substantially disadvantaged on dairy market access into South Korea in comparison to the agreements made by the EU, USA and NZ.

Australia did not gain any market access improvements for SMP (MFN = 176%) WMP (MFN = 176%) or Evaporated/Condensed Milk (MFN = 89%).

The EU, USA and NZ all negotiated CSQs for these products, with 0% tariff within quota.

Where Australia did manage to negotiate CSQs, the implementation time lines are behind the EU and USA - both will enjoy 0% tariffs on several products from 2021.

Even compared with the NZ Agreement which EIF a year after Australia's the implementation timelines for CSQs are longer for Australia on Butter, Other fats and oils and Cheese.

NZ will reach 0% tariff on several lines before Australia does.






